ACKNOWLEDGEMENT OF HAZARDS-ASSUMPTION OF RISK

WAIVER OF LIABILITY FOR *Colorado Plateau Photo Tours* A LEGAL DOCUMENT

Significant efforts have been made to give you a rewarding experience, yet there are risks to you and your property that in extreme cases could lead to the loss of your property, permanent trauma/injury or even death. In consideration of being accepted as a client with *Colorado Plateau Photo Tours*, I the undersigned hereby agree to the following:

ASSUMPTION OF RISK- I hereby acknowledge, accept, and agree that the activities of hiking and camping [H/C] (hereinafter referred to as "H/C") involves inherent risks including but not limited to:

- a. All manner of traumatic injuries even including the possibility of serious permanent injury and/or death, as the result of falling from and/or hitting rocks;
- b. Permanent injuries, illness and/or death resulting from camp food, animals, reptiles, or insects even including the possibility of serious permanent injury and death;
- c. Failure to follow instructions, failure to ask for instructions, or clarification;
- d. Permanent injuries and/or death caused from falling rocks, falling trees, ice, Snow, wind or flash floods;
- e. Permanent illness and/or death caused by altitude illness.

I further acknowledge that the above list is NOT inclusive of all possible risks associated with hiking, and camping and that I understand and accept these risks. I further acknowledge that I have had ample opportunity to ask any and all questions of *Colorado Plateau Photo Tours* staff.

1. **RELEASE-** I hereby release and discharge *Colorado Plateau Photo Tours* its owners, affiliates, agents, employees, and their successors and assigns, from any and all liabilities, suits, claims and demand actions or damages (including but not limited to attorney fees and disbursements) incurred by me arising out of participation in activities associated with these activities (H/C), including without limitation, all claims for property damage, personal injuries or wrongful death even to the extent that such a loss or damages is caused by or results from the negligence of any such party. This release is binding on my heirs, assigns and agents.

2. **INDEMNIFICATION-** I hereby agree to indemnify and hold harmless *Colorado Plateau Photo Tours* its owners, affiliates, agents, and employees and their successors and assigns, from any and all action, claims, demands, losses and costs of any nature whatsoever arising out of or in anyway relating to my activities with *Colorado Plateau Photo Tours* including that caused by the negligence of any party. This indemnification is binding on my heirs, assigns, and agents.

The terms of this agreement shall continue in affect after the trip. The site and governing laws of any suit shall be in and of Arizona. In short, I acknowledge that I cannot sue or collect money from *Colorado Plateau Photo Tours*.
